What to do during an interview.

Employees often don’t perform up to their potential during survey interviews because they are intimidated or don’t take it seriously. This video shows them what to expect during a survey or inspection.

Employees learn that they should be cordial, cooperative, and answer questions fully. They should ask for clarification if they don’t understand a question. Instead of guessing, employees should describe the resources they would use to find additional information.
